- -Martin recommends ads for LACC in Parent-Teachers Associaton magazine, to reach teachers; BofR approves
- -Martin recommends Clinic employ a nurse; BofR approves

1950 (Mar 25-26): Lee H. Norcross, dean of the LACC graduate school, reports on visit to SFCC and CCC (Norcross, 1950):

...Dr. Stump and I visited the San Francisco College and the California College at Oakland.

We were cordially received by Dr. McClintock and Mrs. Russell and there was much of interest to report. May I report particularly as concerns the Graduate School. Dr. McClintock spoke with much enthusiasm of our Graduate School and its program including having one Statewide educational institution. He declared that classes should be held in a College not a hotel and then offered his facilities emphasizing no charge or commitment.

In San Francisco Mrs. Russell in a more quiet way made the same offer "The Graduate School is welcome to our classroom and clinic facilities." Mrs. Russell especially offered one of her anatomical specimens and the use of the dissection room for our Graduate School use.

May I make clear that both Dr. McClintock and Mrs. Russell voluntarily and unsolicited made the above offers and comments on our Graduate School as both Dr. Stump and I acting as your representatives looked and listened, and therefore made no reply other than a courteous acknowledgement.

At the Coordinating Council Sunday afternoon we were asked "have we explore the advantages of holding Graduate School classes in the two northern Colleges?" My answer on the floor was "That was on Dr. Stump's and the speaker's agenda." Sunday evening in the main floor (library) of the Learnington I listened to many discussions regarding holding classes in the colleges. It seemed to be known to everyone excepting (us) that College facilities would be offered at this time. We could hold X-ray, Psychiatry, Iridiagnosis and General lectures at McClintock's, his clinical space is very small, inadequate for any teaching class. Patients would be required to walk three flights, no elevator service Saturday afternoon or Sunday. At San Francisco, clinic space adequate, dissection room facilities would permit a Graduate level class. Elevator service available as the College occupies the entire building.

Among conversations I listened to regarding Bay are extension classes I feel certain that holding the classes at the colleges would stimulate class attendance and would afford facilities for actual clinical demonstration and practical work. It is my belief that it would add favorably on future professional relationship. Reflecting a remark between Drs. Coquet and Hightower that classes suitable to the best available facilities be held at either the San Francisco College or the Oakland College. Further qualifying that this would allay professional political factionalism.

- -Martin agrees to continue as president until a PhD can be employed

-Stump reports trip to Northern CA schools:

...talked with Dr. Percy, Secretary State Board of Chiropractic Examiners and with Dr. Talley, President of the CCA -- had interview with Mrs. Russell on Sunday at 10:00 AM, with Dr. McClintock at 11:00 AM -- and a meeting with the coordinating council at 3:00 PM. Dr. Stump informed the Board of Regents taht Dr. Percy said that there were no funds available to inspect schools -- only requirements to be enforced are those in No. 16 Initiative -- Dr. Percy concerned over the educational requirements of the new law. Dr. Stump observed and listened to the variou sviews expressed by the doctors in the field --Mrs. Russell and Dr. McClintock will acquiesce to one college, request what is necessary to cooperate and fulfill this desire impressions of various members of the field that we should bring pressure on Board of Examiners for enforcing educational standards -the LACC should not present a program setting forth standards or enforce them -- may cause factional strain and division in field -- the majority want only one college.

Dr. Stump presented a plan discussed by the Board of Regents to the doctors of the North as follows -- one college in the State -- main campus and college for teaching theory and didactic material in the southland and clinics established in Oakland or where necessary. Consensus of opinion of Board of Regents that acceptance of Russell school would be a liability. Board of Examiners apparently will set standards of profession at level of inferior schools -- LACC will be laboring under difficulty circumstances of running a school with the high standards we have established.

-Martin's written report notes:

...Physicians and Surgeons Society...has the sympathy of a large number of our faculty and students...The P&S leaders have asked of us what is the use of a 4480 hour course for such a restricted practice and why attend graduate school classes unless it leads toward a less restricted scope of practice? They say that students can get an unlimited medical license for an equivalent course so why invest so much time and money for a chiropractic license? Their leaders are making the claim that only through a broader license, (P&S) can chiropractors become included in the eventual socialized medicine program of both state and nation (Martin, 1950b).

- -Martin's report further proposes that any student or DC who brings in a non-GI student should receive a \$100 tuition waiver or grad school tuition credit
- -Martin proposes LACC name change to: "Pacific University, College of Chiropractic," "Southwest University, College of Chiropractic," or "Southwestern States University, College of Chiropractic"; says Martin:

There are numerous tangible advantages to University rating as differentiated from a "college." To secure these advantages is our reason for selecting University status.

-Houser's written report includes:

4. Mrs. Russell of the San Francisco College of Chiropractic spent three hours in my office on Friday during which time she stated that

she is now of the opinion that there should be but one chiropractic college in California, and that she is willing and ready to cooperate fully to bring this about. She is ready to negotiate on almost any reasonable terms. It would seem necessary and advisable, however, that the students which she has matriculated shold be completed at the college or at some college in the bay area. She had in mind that perhaps we might acquire her college, conduct an undergraduate curriculum long enough to complete the training of those now enrolled and at the same time to use the facilities of the college for the Graduate School work. At the present time they have enrolled 60 students. From a financial standpoint the college represents an investment of \$15,000.00, \$10,000 of which was borrowed from her husband and \$5,000.00 of her own money. The new value of the equipment which she now has is \$11,000.00. The present value, as recently computed, is \$8,000.00. She indicated, of course, that she would like to get out of the college her original investment though she also made clear that she is ready and willing to negotiate.

The Board of Regents discussed the matter of buying the Northern schools -- consensus of opinion of Regents was in favor of setting up a separate schoo for the Graduate School and a clinic.

The Board discussed the matter of offering the North as a means of securing funds for this school problems, 60% of money raised due to the sale of tickets in "Fund-Raising" campaign.

MOTION by Dr. C.B. Eacrett that the Board of Regents authorize Dr. Robert Stump and Dr. Lee Norcross to explore into the possibility of obtaining a clinic building for the Graduate School in Oakland and that we encourage the field in the North to develop this unit of the Graduate School under the direction of the C.C.E.F.

SECONDED...CARRIED

The Board of Regents instructed Dr. Norcross and authorized him to assist in forming a **National Association of Graduate Study**.

-Russell of SFCC speaks to BofR:

The chair entertained advice and plans of approach before asking Mrs. Russell into meeting. Mrs. Russell, owner of the San Francisco College of Chiropractic, was introduced to the Board of Regents by Dr. Stump. Mrs. Russell proceeded to tell board of her problems to procure laboratory license and read a series of letters between she and the Board of Health and the Board of Examiners. General discussion and questions ensued -- Mrs. Russell offered Mr. von Herzen her file of correspondence for his study and perusal.

-Martin's written report to BofR says:

1. A laboratory technologist has been required by the State Board of Health in each branch of our school clinic. Our permit for the Glendale branch is not complete until this compliance has been made. The matter has been presented to Mr. von Herzen to avoid taking any steps which might compromise our position relative to diagnostic privileges granted by our administrative law.

2. Acquisition of the Russell School in San Francisco would give the Bay area graduate school clinic and teaching facilities and personnel to operate the school could be used to assist graduate school administrative problems eliminating much travel expenses. The purchase cannot be consummated without advance approval by the Department of Education of California and the Veteran's Administration.

3. An emissary from Dr. McClintock contacted the author of this report at the convention in Oakland. He indicated that Dr. McClintock foresees that he will eventually be forced to give into the program of educaiton adopted by the profession represented by the C.C.E.F. but desires to remain in teaching capacity when amalgamation takes place.

-Martin's report notes that LACC faculty request free auditing without credit of Grad School course offerings; Martin recommends that the BofR send a letter to Dr. Haynes:

...concerning his outstanding success in securing equipment for the clinic amounting to \$31,000 - \$24,000 of which was at no cost.

Counsel offered the following information -- Attorney General U.S. Webb rendered a decision about 20 years ago that Chiropractors cannot practice obstetrics and offered the following cases. Dr. Shook case acquitted, Dr. Long case acquitted, Dr. Hightower case acquitted, Dr. Rigler convicted on charge of surgery -- episiotomy. Mr. von Herzen recommended that we must sustain the practice of obstetrics in our profession. Recommended further that we remove OB cases from the college until we are sure that the Veterans Administration is favorable to our case.

Board of Regents unanimously agreed that we press our case for legal recognition -- that we do all in our power to maintain OB clinic and that we render all legal assistance necessarily to practitioners involved in court action.

-officers of BofR re-elected

-Martin absent while attending "National convention in Washington, D.C."

-Leo Montenegro heads "Committeee on Research and Evaluation of Treatment Procedures," which has discussed at length the issue of introducing pharmacology courses in grad and undergrad curriculum

-Houser's written report notes:

As you know our obstetrical clinic program has been progressing nicely under the guidance of Dr. Hamilton. Since the inauguration of this service, less than a year ago, there have been a number of

deliveries and the Senior students participating in the clinic have been very active in building up this department. It seems now, however, that we are faced with the loss of hospital affiliations for deliveries. Apparently prressure has been brought to bear on the hospital which we use by the State Department of Public Health who have informed the hospital that since they do not hold a teaching permit undergraduates cannot be permitted to observe activities within the hospital. This naturally is a serious blow to our obstetrical program. At the present moment no solution to this problem is seen.

A great deal of time was spent in discussing the purchase of the Glendale property. Two committees were appointed to investigate some of the factors involved. We hope to be able to soon go ahead with this fine project.

There is one very serious problem facing your college with which every one connected with the college is struggling. That problem is FINANCES. This is not a new problem. This writer well remembers a report given by Dr. R. Stump in 1948 when he ws a member of the Board of Regents. He stated that the time was fast approaching when we would have to find some way of subsidizing the colleges if we wanted them to be rated as institutions of higher learning. That observation has proven to be exactly correct. It is an absolute impossibility (as pointed out in the supplementary report to the C.C.A. Board of Directors) for a college to operate on tuition alone and still maintain the level of education which we all desire for our profession. No other branch of the healing arts is able to do it and neither can we. The chiropractic profession has reached a fork in the road of progress. We must choose which road to take. One road leads to continued advancement and ultimate recognition as an institution of higher learning. The other leads back to the trade school classification. We can have which ever classification we want. If we choose the former, it means that those of us who are in practice must contribute a portion of our yearly earnings toward the cost of providing that type of education ...

Physical planning.

Three years ago the Regents, alumni, faculty, administration and representatives of the profession reached a solid agreement that in addition to the purchase of the property now occupied by the college we would require the building of a training hospital adjacent to the campus. The group present at the meeting concurred with the faculty's reason for the training hospital. The practical training of the future doctors of chiropractic can only be further improved through hospital experience, where the student can follow the progress of in-patients under chiropractic care.

Thus we have reached several definite conclusions in our physical planning. We ahve accepted a general plan for a permanent site for the college. We agreed that the site for the hospital should be given first and urgent priority. We are in accord the the second step should be the buying of the collegesite, to be followed by the building of the hospital. To brush this work aside as so much day-dreaming would be to do something less than justice to the careful and thoughtful work of many people. This general plan and program imposed on all concerned, a responsibility to give serious consideration to the future of the college. That the obligation was not taken lightly I can vouch, and I would pause her to express deep appreciation to the members of the Regents, the alumni, the faculty and the profession who labored so earnestly and generously to advance our plans to the present state of development.

The progress has been slow, for unfortunately the initial funds must be supplied by the members of the profession, which fund will then serve as the magnet to attract monies from other sources. I say "unfortunately" because many members of our profession, not being accustomed to the thought of a non-profit chiropractic college, refuse to accept the fact that no individual or group of individuals are financially profiting from the operation of the college, nor can they recognize that the LACC is not owned by any one person but that it belongs to the profession-at-large. The LACC is much like the University of California which belongs to no one individual but to all of the residents of the State, yet that does not mean that we can walk into the university and individually operate it. We operate it through a Board of trustees, the same applies to the LACC. The perusal of the college's and CCEF's papers of incorporation and the consideration of the meaning of our Federal non-profit status should clear this point once and for all. This condition of misconception is but a sign of a young profession; it is one of the factors that slows down chiropractic progress.

On this matter of financial support fo the college I was happy to see the following as part of the report being preared by the afore mentioned Dean's Committee. "A non-profit specialized, technical institution financially dependent upon tuition is nowaday sin no position to expand or improve its facilities unless additional sources of revenue are available. Colleges that depend solely upon tuition for their support very likely face extinction I this era of inflationary finances. The Committee therefore feels strongly that the continuation of a sound, progressive, educational program will not be assured until there is economic security. The committee points out that this could best be accomplished through the willingness of the profession-at-large to assume a much higher degree of financial responsibility than is now case. Although full aware that some progress in this directin has been made, the Committee cannot stress too forcefully the unavoidable and urgent fact that the responsibility for the future fiscal state of the college rests ultimately with the members of the profession."

The site for the hospital was bought on a shoe-string but through careful management it is now secure. The present income from the rentals of the buildings on this site alost cove rthe cost of maintenance and payments on the mortgage. The value of this land has greatly increased and the mortgage debt is relatively small. The acquisition of this property has been a wise financial investment for the college.

Now we face the second step of our physical program: the buying of the school site. About ten percent of the amount required for the downpayment has been collected. If the speed of this drive is not rapidly accelerated ther eis a good chance that our golden opportunity to purchase a permanent home for the college at fifty percent of the actual valuation of the property will be lost. It could even be possible that the college would find itself homeless. The profession has been slow in responding to our need, which is also theirs. If each alumnus of the LACC would donate but \$100.00, the property could be bought immediately. The profession must be made to realize that their future depends upon the economic security of their professional institution, that the economic well being of the individual doctor of chiropractic depends upon the calibre and stability of their chiropractic colleges. Even as young a profession as osteopathy and optometry have become aware of this basic fact. This is proved by their generous moral and financial support of their schools. They do not contribute a few dollars once in a while, but make yearly gifts averaging nearly two hundred dollars.

Institutional objectives.

In the area of academic development it was inevitable that we should be thrown back to a consideration of our educational objectives and philosophy. Whatever we do must, of course, be within the framework of a chiropractic view of education. Again, while we may expand somewhat, ours is not the problem of mass education. What we are doing is to provide a certain type of education for those who desire it. What we hope to achieve is the development of chiropractic practitioners and leaders who will exert a beneficial influence on the society in which they live. It is our thinking that this influence can be best exercised by men and women whose chiropractic education is founded upon a scientific basis and not on fanaticism. Our immediate concern then, is to present a course on chiropractic along accepted academic procedures designed to develop thinking men and women.

Curriculum.

No changes have been made in our curriculum. Its extent continues to exceed minimum requirements of the law or educational rules of the State Board. Our sequence of presentation, designed to have our students progress from elementary or pre-requisite subjects to more advanced subjects and to the final achievement of the objective of the course, has been approved by the Dean's Committee who state: "The curriculum, both in content and scheduling, is outstanding in comparison with that of other colleges of chiropractic." and again, "The LACC curriculum is well organized as to subject matter and sequence."

For the last two years we have been in contact with the Western Association of Schools and Colleges which is the regional accrediting agency. Dr. Waterman has had three meetings with Dr. Briggs, the Executive Secretary and I had two meetings with Dr. Benson, President of the Association.

They have pointed out the main areas in which an accreditation team will base its evaluation of the college. They are:

- 1. Physical plant Ownership is preferred, though not absolutely essential to accreditation.
- 2. Finances Non-profit institution. The tuition income should not cover over 80% of the cost of operation.
- 3. Salaries To the extent that faculty salaries are computed on the basis of full-time employment, they should not fall below the figures prepared by the American Association of University Professors.
- 4. Library They are interested in the library of a school seeking accreditation as a specialty institution only insofar as academic holdings are concerned; that it, those areas which have their coutnerparts in liberal arts colleges. (anatomy, histology, bacteriology, chemistry, hygiene and sanitation, psychology and possibly nutrition.
- 5. Faculty They are concerned with the academic background of the teachers who give instruction in the basic sciences. They should have at least a Bachelor's degree with a major in the subject.
- 6. Teaching facilities A specialty institution can expect a close inspection in this area, particularly the laboratories. They would have to measure up qualitatively and quantitatively to the facilities appropriate to a liberal arts college of comparable size. Adequate faculty working facilities will be looked for.
- 7. Admission procedures A specilty insitution must require a high school diploma as a minimum entrance requirement. It should have adequate testing procedures to determine the academic and intellectual qualifications of applicants. The High School grade point average must be at least 2.00 (C). The college must require the completion of at least 30 semester-units of transferable non-professional instruction at a college level. By "non-professional" the Association means course-work not considered pre-requisite to or part of the professional curriculum.

Dr. Waterman said: "In general I can report that Dr. Briggs was most encouraging. Basing his decision upon what I told him (and I tried to be as accurate and objective as possible), he willingly agreed to recommend to the Executive Committee of the Association that an accrediting-commission be established whenever we so request. This in itself is a big step forward, since he is the screening agent who determines which institutions might reasonably expect to get accredited. He frankly admitted that it would be difficult to avoid a certain amount of prejudice, although he said that our accreditation committee would be made up of academic rather than medical people. However, he did not feel that any possible prejudice would affect the outcome of the investigation, so long as we presented a fairly strong case."

After discussion of this matter with Dr. Kersey and Dr. Waterman, we agreed to recommend taht the administration be empowered to apply for regional accreditation when they feel the college is strong enough to insure success. Dean

Through the gracious cooperation of Dr. G. Stanley Hesse the dream of amalgamating of graduates of the different California schools under one protective roof has taken another step towards realization.

California Chiropractic College President Hesse, with a view to strengthen the educational development of our profession and desirous of protecting the graduates of his college, has transferred all his students' records to the L.A.C.C. "for that college to act as a permanent reposiory of records for the students of the Chiropractic that graduated or attended the California Chiropractic College." He also wishes that C.C.C. graduates be considered as part of the L.A.C.C. alumni. The college is more than glad to accede to this request.

The L.A.C.C. re-assures the graduates of the C.C.C. of the fulfillment of all its obligations assumed by the amalgamation, including the certification of credits earned.

This amalgamation following that with the Hollywood College of Chiropractic, took place last November fifth. It is powerful evidence of the rapidly developing solidarity of Chiropractic in California. A great debt of gratitude is owed to Dr. Helen Sanders and Dr. Robert Gray of the former Hollywood College for their unselfish action in supporting Chiropractic educational progress and forcibly giving it added impetus.
