1975 (Aug): *ACA Journal of Chiropractic* (12[8]) reports: -"California" (p. 26):

Dr. Kenneth Allen, a Vallejo doctor of chiropractic, delivered the graduation address of the first graduating class of the University of Pasadena on June 29. The ceremonies were held at the Pasadena Civic Center.

The University of Pasadena first opened in February 1974. At present, the chiropractic college is the only one in full operation, but the dean of the university is hopeful that very soon other schools will be opened and that eventually a complete range of academic courses will be available...

1976 (Mar/Apr): Today's Chiropractic (5[2]) reports:

-"University of Pasadena" (p. 56):

... Total enrollment for this term is 179.

Classes are still small enough in this new chiropractic college to be intimate and personalized...

Quality education has provided six willed cadavers from the University of California School at Irvine, which the dissection class shared with underclassmen.

Growth comes with the offering of clases in the School of Natural Sciences, which has been founded under the University of Pasadena to provide courses for prospective chiropractic students who lack the necessary undergraduate prerequisites in the biological sciences.

A change is being made in accordance with CCE regulations. Night classes are being phased out. The last night class will graduate in June 1978...

Guest lecturers enhance the University of Pasadena education and chiropractic outlook. Recent speakers include **Reg Gold**, D.C., vice-

president of Sherman College of Chiropractic, who spoke on "How Big Is Your Vision?"; **Bernard Jensen**, D.C., N.D., active in the fields of nutrition and iridology, who spoke on "The Whole Man"; H. Patak, D.C., teacher at **Los Angeles College of Chiropractic**, who spoke about naturopathy; and **Richard Van Rumpt**, D.C., director and founder of the Directional Nonforce Technique, who enlightened students on the history of chiropractic...

- -"A special tribute" by Jay D. Kirby DC notes death of **George Haynes** DC, MA in May, 1979, and that Haynes was member
 of the PaCC board of trustees (p. 28)
- 1980: JG Anderson DC, ND left AECC, began as part-time instructor at PaCC, then full-time (Anderson, 1995)
- 1983-86: JG Anderson DC, ND serves as dean of PaCC; becomes Dean Emeritus in 1986, replaced as dean by Don Reas DC (Anderson, 1995)
- 1984 (Aug 19): letter from A.E. Homewood, D.C., N.D., LL.B. to Ralph J. Martin, D.C., N.D. (in my Martin file); includes: ...Jay Kirby has kep me informed of the migration of the former LACC staff to Pasadena. They are a good group and should be a real asset to P.C.C...
