

Dear Doctor:

Your favor of Dec. 1st duly to hand and noted. Yes, we well remember you at the meeting of the **P.S.C.** Convention two years ago. You will note we say **P.S.C.** instead of **U.C.A.** from the fact that **B.J. Palmer** has always owned that association body and soul. That fact was no better demonstrated than at the above mentioned convention.

In all my life I never saw a more disgraceful prostitution of the voting franchise. The student body and many of the visiting Chiropractors waited in every instance until **B.J. Palmer** told them how to vote. This cannot be contradicted from the fact that on three occasions up there, they had the poor little fellow so rattled that he led them astray and voted down his own motion. However, after he had awakened to what he had done, the motion was reconsidered and they just as cheerfully helped him out of the hole. The whole bunch of them should be disfranchised. People of that kind have no right to have any voice in the government of any country.

From your letter we take it for granted that you are a staunch advocate of legislation without compromising with the Medical Trust. This being the case, the second paragraph of your letter is incorrect because we have never since the organization of this college been at variance with anyone else favoring legislation.

The **International Chiropractic Association** was formed, as you know, during the week of the convention of which you speak; you were in attendance at the first meeting. There was incorporated in the constitution and by-laws an article that stated most emphatically that one of the objects of the association was to work for legislation for Chiropractic, and it has ever since stood for it in an uncompromising manner.

At the time of the organization of the association of federated Chiropractors, an invitation to attend the first meeting was extended to many or perhaps all of the members of the

International Association. The objects of the proposed federation were an exact copy of those already incorporated in the **International Association** which at that time had over four-hundred members and was in good, flourishing condition. This fact was called to the attention of Dr. **Carver** and it was suggested to him at that time that instead of forming a new association that he join the **International** and use all his influence along the very lines that he favored for we felt at that time that organizing another association simply divided the forces and would not make for the best interests of the profession of Chiropractic. We believed that a movement of that kind was ill-advised and we have not yet changed our mind.

The **Universal Chiropractic College** took up the campaign for legislation the day it was incorporated and has lost no opportunity since that time to further sentiment for legislation.


We do not care to question the ability of certain men in the association of federated Chiropractors but we do not believe that the association has a monopoly on talent of this kind. The national counsel for the **I.C.A.** is **Col. Long** and **under his guidance the association has never lost a case.** He, too, is well up in legislative matters and we feel that the subject in his hands will be well taken care of.

Through our suggestion an association was formed in the State of Iowa several weeks ago. To avoid any feeling that might be engendered, the **Universal Chiropractic College** had nothing to do with the association further than to urge on the profession in the State the importance of it, because we did not want anyone to feel the **U.C.C.** was trying to form an association of the kind to further its own interests.

We have been repeatedly opportuned to join a National Association with its headquarters in Pa. The same object is advertised, namely legislation for Chiropractic. The question of legislation for Chiropractic is today the paramount issue, but the American Medical Trust is not our worst enemy in our fight for laws. The worst enemy is the **faker in the Chiropractic school business, and the prince of all of them is B.J. Palmer.** There is little doubt but what when you go before the legislature with a prayer for laws you will be met by your enemy with the advertising matter of the "Fountain Head". **This same individual has done more to degrade the profession and Chiropractic than all other agents combined.** So far as we know the **International Chiropractic Association** is the only association in existence that has stood uncompromisingly for legislation for Chiropractic. It is well officered, not run in the interests of any school or individual and has a large membership, and we believe that it is today in the best position to lend yeoman service to the Science of Chiropractic than any other association, and regret exceedingly that instead of organizing other association the champion of legislation for Chiropractic did not join forces with it instead of dividing the members of the profession. However, every honest endeavor along this line has our best wishes so we sincerely hope that in your endeavor for laws you will be successful.

1913-14?: **Loban** (as executor of DD's will) files suit against **BJ** (Gielow, 1981, pp. 125-7)

1914 (Apr 23): letter to **BJ Palmer** from **TF Ratledge** DC, with brief comment from **BJ** at the end (Ratledge papers, Stockton Foundation for Chiropractic Research):

Dr. B.J. Palmer, D.C., Ph.C.

April 23, 1914

Davenport, Iowa

Dear Doctor:-

Before me is a letter from the "U.C.C." in which they state a purported "Chiropractic advertising campaign" in the press and it, as is usual with their literature, is full of inconsistencies to such a degree that I could not refrain from expressing to a small degree my regrets that our noble profession must constantly be burdened with such, for the thinking public are not blind and with the most casual observation will see the "Nigger in the woodpile."

They hold this proposition open to any one who wishes to advertise as a Chiropractor without asking anything in evidence to support the contention that they (the advertisers) are actually Chiropractors or are practicing Chiropractic, and knowing that a large number of persons are pretending to be Chiropractors when they are really only masseurs, bath-house artists, etc., it is obvious what the effect in such communities will be; and too, they will "CAST A MOST FAVORABLE REFLECTION UPON THE NAMES MENTIONED."

They explain that they are going to use six inches of space, (How much did they use at the expense of the other fellows, at \$10 per?) in telling that "the U.C.C.", (although born of a most disgraceful episode in which a junior member of a faculty together with a number of disgruntled students who wanted to teach their teacher, as are found in every class, out of revenge started a school and are now "the leading college of the profession", which (if this were true) is to be pitied; then goes on to say that they have a "three and four year course." Now, if it takes three or four years to become a Chiropractor, how can they honestly "cast a most favorable reflection" upon men of whom they know nothing; and it is certain that the pseudo is anxious to get his name listed with Chiropractors.

What explanation can be offered why it should take four years to educate Chiropractors now when they have been, and if I am correctly advised, are still "doing it", graduating them in one year? If it requires four years in the future, then they admit that they have been guilty of graduating incompetent men, turning them loose upon an unsuspecting public just because some one else did, or perhaps for the more selfish purpose of obtaining money. Then, what are they now still going on with this policy for? and it cannot be construed any other way, when they are going to graduate those who so desire at the end of THREE years when they should go Four years? It would be just as honest to do as Dr. A.A. Gregory, of "Thirty Day Fame" does in graduating those

who desire it within thirty days, for the only difference is in degree.

Legislators are no so easily deceived as some of our inexperienced "legislative enthusiasts" who have never done anything but talk about it, seem to think, that just the mere advertisement of a "long term school" will have any weight, what the legislators want to see is some men who can demonstrate the merits of Chiropractic by properly representing it before them, and all the advertising under the sun will not secure legislation, nor will the school which seeks legislation through such weak measures receive any serious consideration from the profession.

This school, The **R.S.C.S. teaches only one class of Chiropractic which is twelve months** to all, and when it is found necessary to extend the time in order to educate the student better, we will advance the length of term and make it applicable to all matriculants and not turn out some half educated, others three fourths educated and finally, some who have enough money to go four years and the time to spare, turn out SOME really educated Chiropractors. "INCONSISTENCY! THOU ART A JEWEL!!!!?"

The letter also says "the first part of the write-up will be a masterly article on the Science of Chiropractic," that sounds good but, if we are to judge by the past efforts of "The Leading College" it is safe to predict that it will be a lot of therapeutic, drugless healing, medico-chiropractic jargon and the dear people who should be enlightened by it will only be the more confused, for it has never been my good fortune to see anything strictly or fully Chiropractic issue from that source yet, not withstanding that they edit "Progress" which instead of being CHIROPRACTIC propaganda is just "Drugless-Healing" therapy or "Chiropractic Drugless Healing Methods."

The greatest danger to Chiropractic is just such institutions as this U.C.C. who inject into their instruction, under the label of Chiropractic all the little things that they can pilfer from other professions without taking the work in regular schools of which they are a part. This confuses the mind of the student and the laity and causes the Chiropractor to be looked upon about as the Naturopath who just does "anything Natural" without having any scientific reason for it and the only excuse offered is that it is "natural", just the same reason that some men are criminals, but not to be tolerated because it is "Natural."

These self appointed "Dictators" in Chiropractic, or rather usurpers of the "Leadership" should be informed that in order to secure and retain the respect of the Chiropractic profession, they will have to prove their faith by their works and not think that "advertising" will blind us to actual conditions and that just "talk" will get legislation and otherwise be beneficial, when in fact we all know that they have done absolutely NOTHING but try to tear down, malign and assassinate the Characters of those who should happen to be in competition with them or have ideas different to theirs. What we need is men who are constructive and do not let their animosity rule them in matters pertaining to our science.

Another deplorable incident is, the vitriolic attack upon yourself in a recent letter purported to be from **Col. Sol Long**, but which smacks of "U.C.C." in which he asks the profession to decide, as between yourself and himself, whom they will support, and issuing an ultimatum of that Character raised the question in the minds of the Chiropractors at large, who is this man? and upon a little investigation it is found that he is not even a Chiropractor and is evidently not big enough to refrain from entering into little controversies which grow out of competitive jealousy. He never has done anything for which we should be under special obligation to him and according to my advice, has not even been connected with any Chiropractic endeavor prior to two years ago, and you can be assured that there is not one of the profession who will listen to such childish appeals as this, coming as it does from an Attorney who is in the employ of some of your unscrupulous competitors.

Dr. Palmer, you know that I fail to agree with you in many details and also with Dr. Carver and likewise with many others, but, you will never find me at variance with you on the main issues, which to my mind is to keep Chiropractic from becoming confused with drugless healing in general and ultimately absorbed by its various cults through compromising legislation and compromise instruction such as the U.C.C. advocates in offering to prepare its students to pass medical examinations before the various State Medical Boards and to accept such legislation, which would be an admission that the Medical Boards were capable to examine Chiropractors and that our contentions of being a separate and distinct profession, whose principles are entirely apart from Medical and Drugless Healing, are merely subterfuges whereby we may go out and prey upon an ignorant and suffering public.

If Chiropractic is not all that we claim for it in its relation to therapy, then it is nothing and we are imposters of the rankest kind and laws should be passed which would force us to attend "regular" therapeutic schools and be responsible to therapeutic examiners in the various states, then, on the other hand, if we are honest with ourselves, and God forbid that we not be, we should not be traitors to the suffering people who need Chiropractic and to those who have entered the profession upon our representations that Chiropractic is a Science and not Therapy.

I consider the school which advocates that the Chiropractors capitulate to the Medical Trust by offering to be examined by them as **TRAITORS**, or so ignorant and short sighted that the profession should crush them out of existence by giving their support to those who are **KNOWN BY THEIR WORKS** to be honest in their intentions toward our great science.

All of the correspondence schools in the world could not do the ultimate injury to our profession and to the public as the man who cries "higher education" when at the same time he is toying with the enemy, sacrificing our principles upon the altar of greed and avarice, actuated by a desire to gain money and power, to appeal to the uninitiate by catering to their preconceived views as to how much time it should take to learn of the human body and its functions, and mixing three years of Therapy with what small vestige of Chiropractic that they have been trying to teach, which policy, if it should go unchallenged and did prevail would result in the absorption by the A.M.A. and allied Osteopaths, and final destruction of Chiropractic.

The man who is willing to sacrifice principle is a coward and when you find any man compromising under such circumstances as those which relate to Chiropractic legislation at this time, you may know that that yellow streak is extensive and that he is whipped before he enters any contest. We should ostracise any man whom we find attempting to compromise our science, for we know that it is for personal gain or else inability to analyze or he would not do it, and we should have none of it, for we will have to constantly watch him to keep him from selling us out at some critical time, so better eliminate him first to protect ourselves, as it is difficult to always be in a position to restrain such characters at the proper time.

It is unnecessary to mention it, for you are aware of the fact that ever since 1908 that I have been an ardent supporter of Chiropractic legislation and have carried the fight into the legislatures of Oklahoma, Kansas and the great State of California and it has been a source of no little amusement during the last year or so to listen to the constant cry by the U.C.C. that they were "the only people who had ever been in favor of Chiropractic legislation" when they have never made even one single move of any substantial character to secure any kind, and I fear that you will have to spend more money to keep them from compromising and accepting anything that the A.M.A. has to offer than you will in an entire campaign to get specific Chiropractic legislation, with

separate Chiropractic Board, examinations to be conducted Chiropractically, etc.

There has been only one general legislative period in the different states since the "Accident" or birth of the U.C.C. and the absence of any activity other than the plaintive notes issuing forth regularly from Mr. Moyer, were particularly conspicuous because of their absence from all the state legislatures, and to this good day we see them just whining, whining, asking the support of the Chiropractors of the world so that they may destroy one **B.J. Palmer** who seems to be unwilling to have performed upon him the delicate operation of having removed his self-respect etc., and join in the sacrifice to the "God of Fear" and submit to medical dictation as we surely must if we ever are inveigled into any kind of a coalition with the Medico-Osteopathic-Drugless Healing Mungrelism as they advocate when they offer to prepare for a stipulated sum, students to sell out their professional identity and go humbly on bended knees to State Medical Boards, composed of men educated in ignorance, and ask their blessing.

And they would have us believe that they are "elevating" the profession; "kind Devil, we pray Thee deliver us from our fool friends," should be our prayer, and let us not cease to wach as well as pray.

The California Federation are very active now preparing for the legislative campaign next year and you may always know that we will accept nothing short of a separate State Board of Chiropractic Examiners and provided further, that all examinations shall be held according to Chiropractic teachings and by that will be meant Chiropractic Anatomy, Chiropractic Physiology, Chiropractic Pathology, Chiropractic Bacteriology, etc. everything will be distinctly Chiropractic and in no wise Therapy.

We have had one arrest lately upon the charge of "unlawfully practicing, attempting to practice and advertise and hold himself out as practicing a system or mode of treating the sick and afflicted in the State of Cal." without having the authority of the Medical Board. This case is going to be fought to the last ditch and am firm in the belief that the A.M.A. is riding to a fall, from the effects of which they will never regain their complete equilibrium.

Will keep you posted as to developments and we expect to show to the Chiropractors of the world in 1915 that California is on the Chiropractic map. Will have a proper committee to meet your train and act as your escort into the Golden State.

Now, Dr. Palmer I know that you are amply capable to fight your own personal battles, but when I witness such utter falsehoods as have been issued against you continuously for the past several years, and when these same falsehoods are jeopardizing our profession and science, then I wish to let you know that you do not stand alone and the entire Chiropractic profession would arise as one and join forces in protecting Chiropractic from such vandals whose every act has been a menace and a prostitution of the great truths upon which our beloved science is based.

The Chiropractors of California are with you and I felt that it would not be amiss for you to know it at a time when you seem to be the center of such unwarranted, vicious and unjust attacks as you have been lately.

We all appreciate your position relative to Chiropractic and though you may have erred, which is human, we know that back of that is a love for Chiropractic which will soon cause you to see the error of your way and give you the courage and manliness to reverse yourself if necessary to advance and do justice to our greatest of professions.

Wishing you deserved success in your great work and that our opinions of you may never lessen and that our respect will continue to grow, and awaiting the greatest Chiropractic reunion in 1915, I am,

1914 (Dec 28): **Loban** dismisses suit against BJ (Gielow, 1981, p. 127)

1915: **Hugh B. Logan** graduates from the **Universal Chiropractic College** in Davenport IA; practices for a few years in Atchison KS before locating in Los Angeles (Rehm, 1980, p. 294)

1916 (Mar 8?Apr 8?): **Fountain Head News** [5(9)] includes: -"A Challenge - in Three Acts" (pp. 7-10) provides a reprint of an investigation of three chiropractic schools in Davenport: PSC, **UCC** and the Davenport College of Chiropractic which appeared in the **JAMA**, 12/25/15 issue; notes that the **UCC** building is "fair size," but there are only two classrooms; 135 students enrolled; only two microscopes; that there is no access to hospitals; no dispensary facilities; that only a "common school" education is required for admission; that dissection is limited to "a few dogs"; that embryology, bacteriology, pharmacology, microscopic diagnosis, pediatrics, gynecology and surgical anatomy are not taught; that physiology and physiological chemistry are taught only by lecture:

Universal Chiropractic College:

They are not in any way equipped to give the character of instruction that would make their graduates safe advisers to the sick...

UNIVERSAL COLLEGE OF CHIROPRACTIC:

Inspected November 24th, 1915

Their records show an enforcement of a minimum twelve months of resident course.

Clinical material abundant.

Equipment fair.

Their faculty is of a higher order of intelligence and it was the only one college inspected in which every statement made was verified by subsequent investigation...

UNIVERSAL CHIROPRACTIC COLLEGE

Located, No. 528 Brady Street, Davenport, Iowa

Inspected November 25th, 1914

Incorporated in the year 1910 under the laws of the State of Iowa. The list of incorporators to be furnished later.

Mr. P.H. Sandford is Manager and Dr. R.E. McNamara is Dean.

The entrance requires a common school education. A residence course of twelve months continuous training is required with an optional course of eighteen months at same price. The fee is \$250.00 per course.

The evidence of attendance, both as to attendance at lectures and clinics, was checked off.

They have fifty-four students in the first year; forty-three in the second year and thirty-eight in the third year.

The faculty and Colleges from which they allege to have graduated are as follows:

J.M. Loban - The Palmer College of Chiropractic.

B.E. McNamara - The Palmer College of Chiropractic.

J.L. Denlinger - The Universal Chiropractic College.

W.E. Carter - The Palmer School of Chiropractic.

R.B. Miller, M.D., place of graduation unknown.

Except Dr. Miller the faculty are all time men.

The records of attendance and the records of examinations were carefully kept and inspected. They will permit but a total of fifteen days' absence in the consecutive twelve months of study.

They have never conducted anything but a residence course.

They have a minimum course of twelve months consecutive teaching, and an optional course of eighteen consecutive months at the same price.

The cost of the complete tuition is \$250.00.

A list of students and date of entrance was promised.

They are the owners of this property occupied, for which they paid twenty-six thousand dollars. It was formerly a library building and is fairly well adapted for the purpose for which it is used.

They have no financial endowment.

They give advanced standing to medical doctors, in contagious diseases and in diseases they are instructed not to personally treat, by a medical doctor.

No instruction is given in accident cases, except first aid. They are not instructed in minor surgery, asepsis, obstetrics, or venereal diseases. Their students are instructed not to attend.

A few lectures are given in toxicology.

They have no chemical laboratory, but a few chemical and test tubes.

They have a medical library of about two hundred medical books, many of them modern and upon the subjects best fitted for them. The library is accessible to the students at any leisure time.

Occasional dissection of dogs is done.

They have no museum except a few spines and skeletons.

They have a fair supply of charts and a manikin.

They have stereopticon and a reflectoscope.

They have one high power microscope and a few slides.

Hygiene and contagious diseases are taught for two hours a week for the entire year.

Their card index system shows that they have now under care, two hundred and sixty-four clinical cases, and they claim that this represents the usual number of under treatment. Many of the cards represent a diagnosis as would be made by a medical man, as well as the supposed spinal lesion.

I found the claims made in the office, previous to inspection, more accurately substantiated by a subsequent inspection than in any other of the Chiropractic colleges I inspected.

Dear Doctor: Hagerstown, Md., August 23, 1916

As stockholders in THE U.C.C. you and I are interested in the welfare of the school and the continuation of its name for the purpose of having something to back up the diplomas we hold from the school.

You are aware of the fact THAT THE SCHOOL HAS BEEN AND IS IN CONSTANT DANGER OF FORCED BANKRUPTCY. IT HAS NOT BEEN A SUCCESS FINANCIALLY and under the present form of organization does not bid fair to do any better. YOUR STOCK AND MINE IS NOT WORTH ONE CENT ON THE DOLLAR AND THE

LIABILITIES OF THE SCHOOL, INCLUDING THE EDUCATION OF THE PRESENT STUDENT BODY, ARE FAR IN EXCESS OF THE ASSETS.

Now then, I have been putting some thought into the matter and have a plan in mind meeting this unfortunate state. The plan involves a condensation and reorganization of the corporation, thereby enabling the business to be transacted more efficiently. The question now is, WHAT IS THE LEAST YOU WILL TAKE FOR YOUR STOCK, also will you give me an option on the same for 90 days from the date of your reply? It will be necessary for me to hear from you in a very few days in order to accomplish this.

Think this over for 24 hours and then write me just what you will do. REMEMBER THE STOCK IS NOW WORTHLESS AND THE GOOD NAME OF THE SCHOOL IN DANGER. It will still be worthless unless it can be made to represent a little value by this reorganization, so make your price a nominal one, to advance chiropractic edy and still further raise the standard in the eyes of the profession and the public.

Please let me impress upon you not to pigeonhole this indefinitely, but let me hear from you immediately.

Yours for Quality Chiropractic, H.B. Ingalls.

The Moral- Having prospective students to send to study Chiropractic, you want to be POSITIVE that they will get what they pay for; will finish that which they start at the place where they pay their money; that they will have a school which will be in existence AFTER they get into the field.

You KNOW the P.S.C. is growing, thriving, flourishing - that it HAS a future. You who are U.C.C. graduates, no matter how loyal you may be to your Alma Mater, cannot afford to send students to a school which cannot live and have these very friends become YOUR enemies when the school fails by "forced bankruptcy" and they are dumped out in the cold, cruel world.

You may send your students to The P.S.C. KNOWING that they will be courteously treated, that they will finish their course in the school they start in; that The P.S.C. will back them up in the future as it has for 21 years in the past. THE U.C.C. REPLIES TO DR. INGALLS.

Their reply follows:-

Davenport, Ia., Sept. 6, 1916

TO THE U.C.C. STOCKHOLDERS:

Greetings:

You have all received the letter sent out from Hagerstown, Md., and signed by H.B. Ingalls, D.C., a stockholder in this institution. This letter was sent out just at the time of the September enrollment and, of course, was used by a local competitor to injure us but we have become so used to such tactics from that source it does not longer attract attention, only to amuse. HOWEVER, WE CANNOT SEE WHAT OBJECT DR. INGALLS COULD HAVE HAD IN SPRINGING SUCH A COUPE AT JUST SUCH A TIME. (1) We hope that you have refused to be stampeded by this letter and have given no options to any one, for upon request to name price for his stock, Dr. Ingalls has refused to name price, saying that his book is NOT FOR SALE. Queer isn't it when he tells you your stock is worthless?

Can any of you see a "nigger" in the woodpile? The U.C.C. has gained an enviable reputation throughout the United States. State authorities where licenses are granted to Chiropractors place the U.C.C. at the head. Throughout the profession the U.C.C. is known as a splendid institution teaching high quality Chiropractic; even its enemies must concede that its teaching is standard, that it has never departed from its established standard, that it is "true

blue" in every respect. THE NAME OF THE U.C.C. IS AN ASSET WORTH A GREAT DEAL OF MONEY (2) and the individual who can gain control, or three or four individuals who can gain control, will fare very well indeed. WE HOPE THAT YOU HAVE BEEN WISE ENOUGH TO RETAIN YOUR STOCK. If it isn't worth anything to you, it is rather surprising that it is worth so much to H.B. Ingalls that he refuses to sell. TAKE OUR ADVICE AND KEEP YOUR STOCK, otherwise it will be used to enrich the other fellow. In a few days you will receive a "news letter" from the U.C.C. containing the full story.

COULD I INDUCE EVERY STOCKHOLDER TO TAKE AN ACTIVE INTEREST IN THE U.C.C. IT WOULD NOT BE LONG BEFORE YOUR STOCK WOULD BE WORTH \$1.00 PAR. BUT WHERE YOU DO NOT EVEN SHOW ENOUGH INTEREST TO WRITE AND INQUIRE INTO THE AFFAIRS OF THE INSTITUTION OR TO SUPPORT IT BY SENDING STUDENTS YOU CANNOT EXPECT IT TO FLOURISH AS IT SHOULD OR COULD OR WOULD BY ENTHUSIASTIC COOPERATION. (3) The new Board elected Sept. 2nd is W.F. Ruehlman, President; C.A. Barnes, Vice-President; W.E. Carter, Secretary-Treasurer; G.M. Otto, Assistant Secretary-Treasurer; H.A. Hackett; W.I. Runnells; J.H. Denlinger.

Dr. Ruehlmann was appointed Manager. Dr. Carter, Dean of Faculty. Dr. Otto, Registrar. With these men the Directors believe the U.C.C. has a better and greater future before it. They will give their entire time to the U.C.C. and earnestly request your cooperation. Fraternally,

(1) IF THE U.C.C. is in flourishing condition, let them produce a financial statement to the Stock Holders. It is to be noticed, that, in Dr. Ingalls "springing such a coupe at just such a time" that he KNEW what he was talking about OR The U.C.C. would have denied his statements, refuted his ideas with facts and figures.

(2) A statement of the assets and liabilities of The U.C.C. would PROVE that statement. Making idle statements, neither proves a thing.

(3) This ENTIRE paragraph SHOWS, by admission, that the institution is anything but being in a flourishing condition. It is pessimistic in the extreme. 1st, it shows that The U.C.C. can't get EVEN ITS STOCK-HOLDERS to take an ACTIVE interest. If stockholders don't, how can you expect the students who are but casually interested? 2nd. It shows that stock IS NOT worth "\$1.00 par" at this time after some 5 years of existence, each year of which has shown a decrease in actual enrollment business. 5 years should have made this stock raise, many times, as has P.S.C. stock. 3rd. It shows that stock-holders don't take "enough interest to write and inquire into the affairs of the institution." When the stockholders realize that their stock is BELOW PAR, not worth the \$1.00 they paid for it, how can The U.C.C. expect them to "show enough interest to write?" 4th. It shows that THE STOCKHOLDERS do not "support it by sending students." All of which is true, for many of them are actually sending STUDENTS TO THE P.S.C. INSTEAD. 5th. It shows that by, these negative statements, alone that The U.C.C. is NOT in a flourishing condition because the stockholders DO NOT support it, let alone the public at large who have NO financial interest. 6th. By admitting that "you cannot expect it to flourish AS IT SHOULD OR COULD OR WOULD" that it is, by inverse ratio, doing the opposite.

This letter is a self-contradiction. Not that "The name of The U.C.C. is an asset worth A GREAT DEAL OF MONEY---" then note that "you cannot expect it to flourish" when even the stockholders don't support it. We are strongly inclined to believe that the evidence of THIS REPLY ALONE supports Dr. Ingalls in KNOWING what he was writing about in the first letter above.

BEING A STOCKHOLDER OURSELVES WE WOULD LIKE TO SEE THE U.C.C. COME FORTH WITH A FINANCIAL STATEMENT, OVER THE SIGNATURE OF AN ACCREDITED AUDITOR AND THUS PUT THE KIBOSH ON ANY AND ALL STATEMENTS TO THE CONTRARY.

IF THEY ARE STRONG, FINANCIALLY, THE BOOKS WILL PROVE IT. IF THEY ARE IN THE POSITION ACCREDITED TO DR. INGALLS, THEY WILL CONTINUE TO BE FINANCIALLY SILENT AS THEY HAVE BEEN FOR THREE YEARS.

Being a Stock-holder, as we have said before, we receive these communications. Instead of being kept private, they are of public interest, therefore we pass them out.

As you know there has been **for some time, a question of the survival of the U.C.C.** and various plans have been discussed for saving the institution.

At the present time a plan is afoot for the Pittsburgh College of Chiropractic to take over the U.C.C., move the students to Pittsburgh, paying their fare- take up and continue in general, the educational policy of the U.C.C. and perhaps most important of all, to operate under the name of the UNIVERSAL CHIROPRACTIC COLLEGE.

This, as you can see, will preserve the value and identity of the diplomas already issued; will move the school **from a bad location** to a good one, **and remove it from close apposition to Palmer.**

Most of the principal stockholders of the U.C.C. **have agreed to this change** and it is clear **that unless something like this is done there will be an involuntary bankruptcy out there soon.** We all have too much regard for the old school to see that happen.

Now, Doctor, a good many of the old stockholders have donated their stock or intend doing so to further this move; others have merely consented that the deal should go through and their stock be rendered permanently void by the change.

What is your attitude as a stockholder?

You are quite at liberty to talk this over with any other stockholder or friend of the U.C.C. **but of course it would be best if its enemies should know nothing about it in case of a possible slip somewhere.**

Jack proposed La Crosse, saying that you had invited the Bd. to meet there, etc. I appreciate your bigness of heart, Tom, but I wouldn't for one minute stand for any member of this Bd. coming to La Crosse, going out to see Fred, or calling them up, or coming to the hotel to see them, or any of them going to the Elks club to have a drink with him -- or in any way any of them doing anything which would embarrass you in even the slightest iota. I am afraid that that would be the outcome in any one of a thousands ways into which Fred would twist the presence of the

Board in La Crosse. Fred is clever in such things and some of our Board would be easy in being led. Fred would be delighted to have the matter twisted too, so color it with local people to still make it appear that the Board was WITH HIM and that it was YOU who had him put out. I wouldn't nor couldn't stand for them doing anything which would give it even the slightest coloring of that character.

We all would be pleased, yea, proud, to meet with you in La Crosse. We would be glad to meet the rest of your firm, know them, get acquainted with them, but this is not the time nor LC the place, not yet for awhile at least.

The Universal School has closed their doors. Bankrupt. Goods are moved out. Gone! Dead! Buried, by gad, buried. I have said "taps" over their remains. This is the end of a ten year fight. It has actually happened and come to pass.

I hope that what I have done will meet with your approval, in regards to LaC, for the Board.

We shall call you in as Legal Counsel if the Boards are willing to meet on this **reciprocity** matter. Meanwhile I want you to figure out how and in what way some sort of a uniform Constitution and By-Laws can be drawn up for such a NATIONAL CHIROPRACTIC RECIPROCITY BOARD OF THE CHIROPRACTIC STATE BOARDS, bearing in mind that the one object is RECIPROCITY amongst boards no two of which have the same standards. Its a ticklish question but I do know that the Nebraska Board is going to take the bull by the horns and pass some Board Rulings even tho they are not strictly according to Hoyle and if they, the HIGHEST AND LONGEST STANDARD, is willing, Brakus should object. "Brakus" being the states with lower and shorter standards.

Get your noodle working, Tom, as much of the success of this Meeting depends upon how you can figure this out. Meanwhile, I suggest that you keep Jan 11th and 12th open time for Davenport. I am, Yours truly,

I have before me the U.C.C. College Bulletin of June, 1920. In it are some malicious misrepresenting statements which I propose to call and deny.

I shall aim to speak so that I will do one of two things with their author. 1st - he will deny my statements or he will ignore them. I am of the opinion he will do the latter, because he cannot do the former. In any event, his refusal to refute will show him up for the cad that I so well know him to be. I will tack on a money bag which will make it well worth his while to show up and prove up.

In this article we find this statement:

"Do you remember that the U.C.C. **first** declared that Chiropractic facts are in accord with Anatomy and Physiology and then proved it?"

THE PSC was the first school to say that there was nothing in Chiropractic which refuted any of the FACTS in anatomy and physiology; that not all the FACTS in anatomy and physiology were known, and that not all that was known were FACTS. *THE PSC* was the first school to add much to the then supposed FACTS and prove them. So far as FACTS are concerned, Chiropractic has no contention, it is to the statements given as FACTS, which are not such, that *THE PSC* contradicted and proved. No person can accept, without question, all that is taught AS anatomy and physiology in medical colleges today AND BE A CHIROPRACTOR.

I will give Joy Loban \$1,000 if he will prove any part or parcel or in toto of the above statements to be wrong.

"Do you recall that the U.C.C. raised the **first** voice to declare that Chiropractic must have licensing laws and even drafted the FIRST bills, whose form **still** determines **every** effort made to regulate the profession?"

Every part and parcel of this statement is a deliberate falsehood. *THE UCA* was formed 15 years ago. It **was** the first organization to get busy on legislation for the states. We understood then, as now, the importance of a proper and intelligent study of the nervous system. We taught then, even in our crude way, an education of the nervous system. Every one of those earliest students will recall this fact to be so potent, that it needs no substantiation. Chiropractic neurology was taught to Langworthy, Smith, Paxton [sic], Parker and others who later ran schools, years before Joy Loban ever thot of studying Chiropractic.

I will give Joy Loban another \$1,000 if he will prove any of the sum or substance of these statements wrong.

"Have you forgotten that Universal Technic is the basis for EVERY form of **diversified technic** NOW USED IN ANY SCHOOL and that the U.C.C. originated, OR FURNISHED THE BASIS FOR PRACTICALLY EVERY MOVE used in adjusting spines except the recoil and the old-fashioned pisiform double transverse, and the 'T.M.'?"

During the past 25 years D.D. Palmer or one B.J. Palmer have developed some 206 different forms of adjustments, not only including those mentioned but including the basis and principle upon which **every move now in use by any chiropractor is based**. Dr. Loban has not, to the best of my knowledge ever invented, developed, originated or schemed out **any** adjustment of **any** kind for **any** subluxation. Dr. Loban had suffered for many years from this malady, but the first severe attack occurred immediately after his election as president of the U.C.C. The disease has been intermittent in character, and the end came from letters written to M.N. Green, of Erie, and to his 43 varieties of graduates on Jan. 7th of this year, in which he talked himself to death.

Dr. Loban was quite renowned as an "I" specialist.

The doctors Milligan and Milligan, Lowery and Battenhouse, U.C.C. graduates, all of whom have enrolled for P.G. courses at THE PSC, will act as pallbearers.

The deceased leaves three crippled offspring, who wi have to depend upon the credulity of the profession for sustenance. They are Miss "Exceedingly Unfriendly Acts" of November, Miss "Intellectual Dishonesty" of January, and Mr. "Following the Star of Chiropractic" in the official organ of the penny ante Club.

Purely because of the connection of Jimmy **Firth** with **Leo Spears**, we thought that there might be some merit in the Spears so-called Painless System. Inasmuch as the writer is the head of the Department of Technique in this college, he believes it imperative that he become familiar with all systems, and notions of adjusting. So in accordance with that thought, we learned this method from Dr. Babcock, who is featured with Dr. **Spears** in the illustrations in the little book accompanying the course.

The course usually takes two to four hours, but as the Doctor was visiting relatives in the city, he came out three different days that we might discuss the system pro and con. Inasmuch as our methods were highly satisfactory and include everything of any value that the **Spears System** includes, we will teach the same system of adjusting that we have been teaching. Our present system of adjusting includes the **Palmer Method**, which the writer learned in the P.S.C., moves and methods of lesser merit from **Palmer's** "Exposition of Old Moves," Dr. **Loban's**, Dr. **Carver's**, Dr. **Gregory's**, Dr. **Riley's** and Dr. **Forster's** works, together with a few points that writer has discovered in his ten years of experience.

Carver and the Colvin and other little hole in the wall schools that follow him are hard to handle and could not agree on definition, etc." (Cleveland papers, CCC/KC)

This explains the reason for The **American Society of Chiropractors**. This society (incorporated not-for-profit under the laws of the State of Ohio) is simply a vehicle through which a national educational publicity campaign may be conducted. It was formed for this single and only purpose as set forth in the articles of incorporation given below.

Dear Ann and Mack;

Will hold the class open this week, This district is having a meeting Sunday afternoon when they expect to sell a number.

The Newark class will hold their banquet at the Elks Club Sat evening at seven thirty. They are going strong. Conover and Loud have not attended class the last week and are dropped from the class roll.

We are nicely situated here, have two room apartment, 22.50 a week, everything furnished, swimming pool and gym in the lower lobby.

Am handling the class here this week until you relieve Fred at Newark, The Newark class will continue one week after this, these that came in there last week will finish the work here with this class, so we will get away from here a week earlier than we had figured on at first.

Just finished dinner here at home and it sure tasted fine, will have one of those mulligans when you get here.

Saborin finally decided to get in the class, He informed Ben that Steinbach recommended Basic Technique very highly in his last letter to him, Looks like some of the letters Steiny received from Binghamton and Elmira class members have had the desired effect, But Steiny is that way, Positive until the burden of proof is sufficient and then he will be for us one hundred percent.

One of the chaps from Conn' believes we should move into that State within three weeks but I don't know how we will be able to take care of Philadelphia and Albany and do that too within two weeks.

Looks like two of us would have to double up on this class here if it grows to the proportions now indicated.

Hope this reaches you in time and that you have not had more than three or four car failures since last we met.

Dear Doctor Logan:-

I have just completed your course here in Denver and find it entirely in accord with Chiropractic. Not one point of instruction is in variance with Chiropractic principles.

In fact, I believe "Logan's Basic Technique" will cure many mixers and make Chiropractors out of them in the "cure."

Being new in the work as I just completed your first class in Denver today, I cannot speak with authority of the permanency of results in chronic cases, but my student work in class and my use

of your technic in my office the last two weeks has convinced me of its value in acute cases.

I am advising my friends here to join your next class which starts next Monday.

1934 (May 29): TF **Ratledge** DC writes (Ratledge papers, Cleveland Chiropractic College of Kansas City):

Gentlemen: Attention: W.E. Hickman, Registrar.

Replying to your favor of the 24th instant, beg to reply that Dr. Logan was for several years a practising chiropractor in this state, having come here from the state of Kansas.

He is of a rather impetuous and aggressive nature and has made both enemies and friends in California. He did **Aquarian Age** teaching in association with Dr. Hurley for a while and then took up this work on his own responsibility, teaching as I understand it, what he himself developed. Dr. Logan is energetic and always active and seems to be the center usually of some turmoil in connection with his activities.

He did some very splendid work in California for which the chiropractors in this state should be grateful. If he has done anything to injure chiropractic, it appears that it could only be due to inadvertance.

His California license was revoked by a former board which in my opinion was purely an act of reprisal against him because they could not suppress him, which they wrongfully attempted to do. The fact of his losing his license in California should cast no reflection upon him.

I know so little of his work that I am not in position to comment on its scientific merits.

Concerning the use of the information given herein, will say that I have no desire to be drawn into any unpleasant controversy or in any way to offend Dr. **Logan**, for whom I hold no personal brief, one way or the other, except as based upon my observation of his activities in the state of California.

1935 (Aug): Homer G. **Beatty** DC, president of the **NCA** "Schools Council" develops standards for chiropractic colleges, and presents these at the **NCA's** convention in LA at the Roosevelt Hotel (Crider, 1936):

...was adopted in principle, specific details and minor changes to be considered later. The final draft by mutual consent to be approved by a joint Committee of State Examining Boards and School heads.

The joint committee is composed as follows: Drs. **HG Beatty**, **A. Budden** and **Jas. Drain** for the Schools and Drs. **WF Crider** of Maryland, **CO Hunt** of California and **FO Logic** of Michigan for the State Boards. The recommendations as to inclusions, rejections and modifications were incorporated.

Visits were made to Chicago and Indianapolis, following the convention, consulting Drs. **Schulze**, **Bader** and **Golden** of the **National**, and Drs. **Vedder**, **Firth** and associates of the **Lincoln**, thus ironing out more of the scales' faults, and obtaining the general reaction after these groups had time to study copies of the scale. It has not been heretofore mentioned that similar tactics were practiced on the journey to the meeting. **Universal** of Pittsburgh and **Metropolitan** of Cleveland were given copies and they forwarded their approval, in principle, of the proposal. Dr. **BJ Palmer** was also contacted with similar intent. However, the astute qualities usually ascribed to him were evidently lacking upon this occasion as he was unwilling to even listen 'to anything that smacked of **NCA**' - in spite of repeated declarations that the **Council of State Examining Boards** on the contrary was separate and distinct from any and all other organizations....

The revised draft was completed and forwarded to members of the joint committee. Other incorporations and modifications were listed. However, it was not possible to incorporate all suggestions.

It is interesting to note that the schools' opinions were still sharply defined and divergent - while the State Boards were unanimously in favor of higher standards.

A synopsis of the Joint Committee's findings is as follows:

1. - **It will be necessary to rate schools teaching the orthodox methods and those teaching the more liberal methods in separate categories as regards list of class hours and equipment.**

2. - All authorities agree, two thousand sixty-minute hours is the maximum that can be taught in three years of six months. This basis, although somewhat less intent, is used in compiling the scale and setting it as regards to curriculum.

3. - It must be comparable with other professions' standards.

4. - The Schools being commercial in character (with very few exceptions) it is necessary to give due consideration to financial stability of the Institutions.

5. - In accordance with the tendency of all state laws, wherever amended, the trend being upward from the three years of six months level, it became obvious the scale minimum for grade A probationary rating must be twenty-four months for the fundamental course and four years of eight months for the liberal course.

6. - In order that all schools may have an opportunity to meet the final requirements of fundamental (three years of nine months) and the liberal (four years of nine), one calendar year - until Jan 1, 1937, is given for probationary ratings of all Chiropractic Schools and colleges.

7. - The scale must be so constructed as to include from the minimum of set requirements to the maximum as taught by an Chiropractic school of today.

The Council of State Boards will not enter into a discussion of the definition of chiropractic. Suffice it to say that each type of thought is recognized and given opportunities to develop. We, therefore, have divided the schools into two groups - the Basic or Fundamental Schools (teaching only Chiropractic) and the Liberal or Physical Therapy Schools (teaching Chiropractic and Physical Therapy)...

1936 (Dec): **Logan Basic Technique Bulletin** [1(1)], edited by Hugh B. Logan, D.C., includes:

A neat little brochure came to hand today, no doubt designed to console friends insofar as possible; our friend and teacher, Joy M. Logan, passed from our midst on July 15, 1936, at Burbank, California.

Joy M. Loban, a sincere exponent of Chiropractic, died at the age of forty-nine years, primarily as the result of an accident, secondarily, as the result of crude, massive adjustment of the sacrum from posterior aspect.

Dr. Loban began his professional career in 1909 as an instructor of palpation and Chiropractic technique, and it will be interesting to know that it was he who initiated the practice of counting vertebrae, a radical departure in those times from dependence upon an appreciation of sectional spinal distortions only.

Dr. Loban blazed the way to a consideration of diagnosis as a necessary subject in the Chiropractic student's training. He was dean of the faculty of the Universal Chiropractic College when I enrolled as the rawest of freshman rookies, was a rigid taskmaster, but was always honest in his Chiropractic convictions.

He has written several books, "Chiropractic Technique," a really scientific compilation of that time, and his "Neurology," which surpasses anything of its kind within the realm of Chiropractic texts even today, among others.

Dr. Loban joined the faculty of the Universal Chiropractic College in 1910, later effected the amalgamation of that school and the Pittsburgh College of Chiropractic, which he managed successfully for many years. He was active in the formation of the American Chiropractic Association, which later amalgamated with the National Chiropractic Association.

Twenty years' acquaintance permits me to conclude that in prosperity and adversity, Dr. Joy M. Loban gave more unselfishly and received less from Chiropractic than any other I know, and it is truly regrettable that the demoralized state of our profession prohibits a fitting tribute to his memory, or appreciation for the sacrifices so willingly made by his good wife and children.

Certainly those favored by his friendship, instruction, and advice, are better chiropractors, men and women, no matter what differences of opinion might have existed otherwise.

I trust that our distorted and mutilated Chiropractic records in this case may be complete and correct, in the interest of one to whom his every student owes much.

A victim of the mad penchant for prescribed massive thrusts upon vertebrae, in this instance designed to move the sacrum anterior, Dr. Loban suffered the effects for years, or until the date of his death.

Dr. Loban came into and went out of Chiropractic expecting from others only a part of that which he gave, and despite our turbulent scholastic and political affairs, was charitable even to his traducers.

He was an honest believer in what he preached – Chiropractic.

Dear Dr. Ashworth:

I am sending you herewith a copy of the Charter, Constitution, and By-Laws of the International College of Chiropractors. You will note from the enclosed that the International College is now a legally chartered, regularly organized, and active institution. We are now doing business and will continue to move along as rapidly as possible. The next order of business is to select a faculty. I am herewith submitting a list of names for the first faculty. I shall expect each of you to write me by return mail your approval of this list, either in its entirety or as many thereof as you desire to approve. The faculty and present officers will serve until our regular election in July which will take place at the Dallas convention.

As soon as I receive a vote I shall immediately notify each faculty member of his election and explain to him what his duties are and what the purposes of the International College of Chiropractors are. I am taking the liberty of handling this correspondence direct instead of relaying it through the Secretary's office in order to save time and to facilitate matters. When the organization has been completed, all correspondence

will then be handled direct by the Secretary in due and regular form.

The officers of the College for the period to our next convention are: Lillard T. Marshall, President, O.L. Brown, Vice President, Harry K. We feel that the future of Chiropractic must be safe-guarded against the dilutions of one kind or another which have been creeping during the past few years and we are generally sympathetic to the program which will serve the purpose of preserving Chiropractic as a distinct set of principles.

Morning Meeting.

Dr. Harring (Missouri Chiro. College) presiding.

Dr. J. Janse was appointed as temporary secretary in the absence of Dr. Beatty.

Proceedings:

1- The meeting opened with the question as to what to do about the Ultimatum as sent to the Board of Directors of the N.C.A. by the Allied Council of Schools, constituting a criticism of the Ass.'s stand with reference to the demand for a scholastic standard of not less than 32 months.

It was suggested by Dr. Budden that a resolution be formed by those in attendance voicing the determination to support the N.C.A. in its stand and insisting that the Allied Council be informed of this decision with the inference that no concession will be made.

2- Letter as written by Dr. Beatty was read by Dr. Harring, suggesting the establishment of a Council on Chiro. Technic. Dr. Budden moved that the Council in form of a resolution suggests to the N.C.A. Board of Directors that a Council on Technic be formulated, with the purpose of investigating and standardizing all forms of Technic as taught at the various schools and advocated by various national technicians.

The foregoing was seconded by Dr. Hendricks.

3- Dr. A. Budden brought up the question about student internship in the various schools, voicing the opinion that internship with remuneration [sic] destroyed the interns' interest to learn, converting his considerations into one of making money. (Question left unanswered)

4- The Question of Basic Science Boards was brought up with the suggestion that members of the various Basic Science states exchange information as to the nature of the questions given, and what textbooks might enable the applicant to prepare himself.

Minutes of the Council on Schools con't 3.

Afternoon Meeting.

Dr. Harring presiding.

Those present:

Drs. Harring, Budden, Hendricks, **Steinbach**, Conley, Cleveland, Janse.

Proceedings:

1- It was moved and seconded that the incumbent officers of the Council be reappointed by general acclamation and be informed of their reappointment.

2- Dr. **Steinbach** asked for discussion on the question of the unification of the type and nature of the various degrees issued by Chiropractic Schools. It was his opinion that the schools could be induced to come to a oneness of thought with reference to this question.

Dr. Budden made the suggestion that attempts should be made to induce the various schools to issue but one degree at the time of graduation, and then after continued work or special endeavor other degrees bestowed accordingly.

He also suggested that the Council of Schools support the idea that the International College of Chiro. be instructed that the council favors their issuing the special degree known as Master of Chiropractic and they only

3- Dr. Harring presented the Council a copy of the Ultimatum of the allied Council on Schools. It was read and denounced by Drs. **Steinbach**, Hendricks and Budden as vicious and assertive.

Dr. Cleveland was asked to clarify his stand with reference to the same and whether he had served as Dr. Kightlinger's proxy at the meeting at which the Ultimatum had been drawn up.

Dr. Cleveland stated that B.J. Palmer, Carver and others met in Kansas City a few months ago and came to the conclusion that the straight chiropractic schools were not favorably treated or represented in the N.C.A.

As a result Dr. Carver was instructed to draw of a Declaration of Rights which was to be sent to the N.C.A. Board of Directors. This Ultimatum was signed by all present, with Dr. Cleveland also adding the name of Dr. Kightlinger per proxy.

Then Dr. Cleveland voiced opinion that Chiro. institutions should limit their educational endeavors to straight chiro. only, denouncing any additional therapeutic measures as being unprofessional. He maintained that exceptional considerations should be extended the straight Chiro. schools, and that many of the influential men of the N.C.A. were of the same opinion. Straight Chiropractic is the only true basis of professional unity he asserted.

Minutes of the Council on Schools con't 4.

At the point Dr. **Steinbach** interrupted and stated that the very nature of the wording of the Ultimatum would evoke the disapproval

Dr. Cleveland then inferred that it had been their opinion that the positive wording of the Ultimatum would bring the N.C.A. to terms. He further maintained that it was the raising of educational standards and the adoption of physiotherapy that induced the medical profession to legislate the Basic Science Laws.

Dr. Hendricks: The Ultimatum was a distinct threat, radical and indiscreet, limiting chiropractic to a 10 finger proposition only.

Cleveland: Ratlich [sic], B.J. Palmer, Carver, Drain and himself were the ones at the Kansas City meeting.

Dr. **Steinbach**: The inclusion of the C.H.B. was but a Palmer bluff, whereby B.J. hoped to eventually regain his general control of the profession as a whole.

Dr. Budden: Graduates from the straight schools unschooled in physiotherapy permiscuously [sic] buy modalities and use them indiscriminately.

The meeting eventually came to a close without any definite decision having been reached other than the one of the morning meeting. Dr. Cleveland was invited to take up the matter with those representing the Allied Council as to whether they will continue to assume their obstinate stand.

1944 (Jan 13): letter from **Leo J. Steinbach** DC to "Members of the Executive Board of the **NCA**" (CCE Archives #35-12-1938):

Gentlemen:

Ever since the announcement of the results of the Detroit meeting of the House of Counselors which appeared in the September issue of the *Journal*, I have been hearing expressions of dissatisfaction from many of the chiropractic school leaders and faculty members. Now that I have read the House of Counselors Bulletin for January and have observed the fact that the storm has actually broken, I feel that I should say something about it to the Executive Board in an effort to help guide the educational program, hoping that its problems and the differences might be satisfactorily adjusted.

I did not attend the Detroit meeting nor the Chicago meeting in 1942 because of school problems. **Universal Chiropractic College** had begun to feel the effects of the war and had fallen so far behind in enrollments that we decided to discontinue operation for the duration. One of our graduates, Dr. George Merrin of Washington, Pennsylvania assumed the responsibility for developing a maintenance and building fund so that we would be prepared to meet the conditions of the new educational program at the conclusion of the war. During 1942-43, we have been finishing out the three year training program of students enrolled in 1941. Our task is just about completed. During the past two years, I have given much thought to the four year standard which has been outlined by Dr. **Nugent**. I have been thinking about it with the experience of 27 years of teaching, research and supervisory work. I believe that I understand how other educators feel now as they face the problem of trying to carry on under war circumstances.

The personnel of every school which did not receive the benefit of complete recognition is more or less disappointed and some of them are quite bitter, as you probably know. Dr. **Weiant** charges in his statement in the recent House of Counselors *Bulletin* that the schools should have been given a 'bill of particulars'. It is true that Dr. **Nugent** made an inspection and

undoubtedly informed the institutions at that time wherein they were short of meeting the full conditions. Dr. **Nugent** visited our school last February and talked with us very candidly about the educational program which he had outlined. In turn, he learned that under present circumstances we could not finance such a program. We informed him that we were making an effort to re-finance and re-establish our college after the war. I assume that Dr. **Nugent** has spoken with equal candor to other school men at the time of his inspections and thus felt that they had been properly advised as to what they must do to meet the conditions for a full rating. We find no complaint on this score.

Knowing that serious differences were brewing between school men, who had given loyal support to the **NCA** in the past, and those of you who are responsible for the decisions and the announcements which have been made in connection with the new educational program, I decided to make a trip to New Haven in order that I might frankly discuss these problems with Drs. **Nugent** and **Wheaton**. We had a two day conference on December 11th and 12th. I believe that we thrashed out every possible angle of the situation which effects the future of chiropractic and its educational institutions. I was only sorry that our discussions were not carried on in the presence of all other school men who are concerned. If they had been there, I am sure that much of the controversy which might develop during 1944 could have been settled.

This will be a climactic year in the history of Chiropractic if the plans which I learned from Dr. **Nugent** can be carried out. As I understand these plans, chiropractic education must be carried on in the future on a basis similar to other forms of higher education. A public ownership plan should supplant the private ownership of colleges. We must find the ways and means to supply adequate funds for the development of chiropractic institutions in order that they might be properly equipped and so that their faculties might be well trained and fairly compensated for their services. **The old order of private ownership, too many schools, competition between schools - taking money out of tuition fees to support state and national organizations** should not prevail in the new future.

It is not difficult for our school to accept the changes which are impending. We have operated as a non-profit institution for the past 16 years. We have also striven for the advancement of chiropractic education and research. The fact that we might be classified as a weak school now is due largely to the standards which we set for ourselves and which could not be made successful on tuition and fees alone. School men should review Dr. **Nugent's** presentation of our case before the **Tolan Committee**. They should also know the problems with which he has been faced before the **New York Assembly Committee** to bring themselves to the realization that all legislation for the recognition of chiropractic and chiropractors now hinges on this point. I believe that other schools will accept the new order once they understand that inevitably it must come.

We cannot just give the profession the prestige and the advantages of the higher educational standard - we must ask them to become philanthropists and support it. It cannot be done on tuition fees alone. I am thoroughly convinced that John **Nugent's surveys and studies of our present and future problems are sound.** The educational program which he has outlined and the plans for its support which were reviewed at our meeting demands our cooperation. A great responsibility will rest upon the Executive Board, the House of Counselors and the profession. I sincerely hope we have the wisdom and will find the strength to see it through.

1944 (Jan 16): letter from **Leo J. Steinbach** DC to **Craig M. Kightlinger** DC (CCE Archives 35-12-1938):

Dear Kight:

I have your letter addressed to the chiropractic schools which were given provisional rating in which you suggest the alternative of meeting somewhere, perhaps Cleveland, or possibly dropping the matter.

When our school was inspected by Dr. **Nugent** last February, he was told that we could not meet the conditions of the new program under war circumstances and that we had actually discontinued enrollments with a planned program of re-organization after the war. From that time until the rating program was announced, we have had nothing to say preferring to let the matter rest with the judgment of Dr. **Nugent**, the Executive Board and the House of Counselors. We were naturally disappointed when we discovered that the **UCC** was not even mentioned in the rating announcement.

Not willing to trust the outcome to a letter discussion, I made a trip to New Haven and held a two day conference with Dr. **Nugent**, Dr. **Wheaton** and three other prominent **UCC** Alumni members. At this conference we learned why we were not mentioned and something more about the plans for the future program of chiropractic education. I came away satisfied that there had been no deliberate attempt to injure or to favor any school. I was satisfied that the development of a higher standard for chiropractic schools and their future operation on a non-profit basis had become an urgent necessity.

It goes almost without saying that chiropractic education could not continue much longer on its present set-up. Neither can the profession nor the **NCA** face its fight to win further legal recognition unless our program of education compares favorably with other branches of higher education.

When I gave my report to our faculty, they were agreed with the exception of one member to follow the suggestions which had been made to me at our conference. Our alumni committee thought it wise to re-plan our program and right now they are in the throes of making an important decision to bring us into full cooperation with Dr. **Nugent's** program. In view of this, I cannot personally favor a meeting of the provisionally rated school representatives.

For a long time, I have felt that the profession should bear a greater share of the burden of chiropractic education and I think the time has come when they are willing to do so or accept the responsibility for the outcome. I have written to the Executive Board and Dr. **Rogers** to that effect and I am willing to leave the matter in their hands. As ever,...

DR. RICHTER PASSES AWAY

Dr. B.R. Richter, 54, of Freeport, Pennsylvania, passed away in the Allegheny Valley Hospital on July 17. He had been in failing health for some months and suffered a stroke in his home, and was at once removed to the hospital where he died a few hours later.

Dr. Richter was a bone and muscle authority of international repute. In the late thirties, he was called to England to treat the Duke of Windsor for injuries received in a fall from a horse. He also treated many professional baseball and football stars and boxing, collegiate football and basketball players and amateurs in all lines of sport.

Dr. Richter was born in Grafton, West Virginia, and became a resident at Greenville, Pennsylvania, at an early age. He was graduated from the Universal Chiropractic College at Davenport, Iowa, and took special studies at Duquesne University.

He served with the American forces during World War I, and resumed his practice in Freeport upon his release from the service.

Besides his widow, Mrs. Iola Richter, he leaves a step-daughter, Mrs. Roger Ruppertsberger, of Freeport, and a step-granddaughter, Carol Ruppertsberger, and a host of friends throughout the country who mourned his death. - Reported by Dr. H.H. Ward, Cleveland, Ohio.

NEW LAW CALL FOR 4000 HOURS

The chiropractors of Pennsylvania were made happy on August 14, 1951 when the Honorable Governor Fine of the Commonwealth signed into law the act House Bill 48, imposing powers and duties on the **newly created State Board of Chiropractic Examiners**. The new act sets up an educational standard of 4000 50 minute hours and in that respect is in keeping with NCA educational standards. Here are the most important provisions of the bill, sent to us by Dr. Leo J. Steinbach, who has worked for the passage of such an act for many years. April 11, 1999

To the Editor,

I thank Professor Keating for his exhaustive and well written paper on James F. McGinnis (1), thus saving me further research into this interesting individual.

I first became interested in McGinnis when I was requested to prepare a platform presentation on chiropractic spinography for the 1992 annual conference of the Chiropractors’ Association of Australia, held at Brisbane, Queensland, whose main theme was “X-Ray ... Exposed.” In researching this subject I was able to establish that McGinnis was in fact, after B.J. Palmer the first

spinographer and instructor in spinography at the Palmer School of Chiropractic. The paper was subsequently published. (2)

There are two points on which I would like to comment: There is a statement in the paper that “It is known that Joy M. Loban, D.C., resigned as chairman of the PSC’s philosophy department and as assistant editor of *The Chiropractor* in order to lead the rebellion that produced the rival institution.” While this sentiment has been voiced at various times, neither Professor Keating nor other writers have ever referenced it to the best of my knowledge. Perhaps Professor Keating can elucidate that mystery at this time.

It has been established that Loban practiced in March 1908 in Keota, Iowa (3), and by May 1908 was located at 2730 Holmes St, Kansas City, Mo. (4), and by September 1908 had relocated to 1813 E. Seventh St, Kansas City (5). By January 1909 he had been added to the PSC faculty (6).

On 8 February 1910 he resigned his position as Assistant Secretary of the Universal Chiropractors Association as he was leaving the PSC for field practice (7), left his faculty position on 15 February 1910 (8), and located in practice at 501 Commercial Bank Building, Waterloo, Iowa.(9)

During 1992 Dr. Mary Ann Chance interviewed her great-aunt, Sadie Chamberlin, DC, member of the class of 1910. She recalled that one day in April B.J., as he had done earlier, made fun of something in the Bible and made some crude comment about women, and she stated that she didn’t like that, and a lot of other students didn’t like it either, and they walked out and formed a new school. So it appears that possibly B.J.’s disregard for the sensitivity of others rather than spinography may have been the reason for the revolt.

My second comment refers to: “He was employed by the Rock Island Arsenal during the first World War, possibly as a photographer.” As Professor Keating does point out, McGinnis set up practice in Rockwell, Iowa, in 1913 or early 1914. In fact he did arrive in Rockwell City, Calhoun County, Iowa on 14 November 1913 and established a practice there (11), and, as stated, he remained there until November 1915, when he relocated to Maquoketa. His correspondence during the years 1916 through 1918, as published in the Fountain Head News, and also as referenced by Keating, all carry a Maquoketa date-line. Therefore it seems unlikely that he worked at the Rock Island Arsenal during World War I.

However, there is a clinical report by a student, M. B. Peterson: “Mr. McGinnis, about 35 years of age, and being a photographer at Rock Island Arsenal, entered evening clinic July or August 1910, having extreme indigestion and severe headaches, also constipation and anorexia, and after one adjustment told me he could not get enough to eat, that he had suffered no headache and a decided benefit with regard to constipation. At the end of two weeks’ adjustment said that he was entirely satisfied with results. Has since matriculated in the school. His case was a chronic condition, experienced for some time previous to taking adjustments.” (12)

It is also good to see Keating reference that McGinnis, although tried in Rockwell City, Maquoketa and indicted in California did not spend time in jail, which concurs with my information, contrary to statements made in another recent paper. (13)

Another small item that may be of interest is that McGinnis acted as pall-bearer in the funeral of William Ambrose Seeley, MD, DC, who was buried at Maquoketa on 8 February 1918. (14)..Seeley had the distinction of being identified by D. D. Palmer as his first graduate.


